WHEREAS, Ordinance No. 97-21 was passed and approved by the City Council on 15 September 1997, allocating the amount of Two Million Eight Hundred Thoundand Pesos (P2,800,000.00) for the emergency asphaltting of the roads in Don Juan Bayview;

WHEREAS, the roads in Don Juan Bayview are used as alternate routes of vehicles coming from Bagumbayan to the Expressway and vice-versa;

WHEREAS, these streets were heavily damaged because of heavy rains due to typhoon "IBYANG". The heavy rains caused strong floods that carried out destroyed asphalt road rendering the said streets impassable;

WHEREAS, the cost of the project is Two Million Eight Hundred Eight Thousand Five Hundred Twenty-Two Pesos (P2,808,522.00) and there is a budget of Two Million Eight Hundred Eight Thousand Five Hundred Twenty-Two Pesos and 30/100 (P2,808,522.30) allocated for the project;

RESOLVE, therefore, as it is hereby resolved, that Mayor Ignacio R. Bunye be allowed to enter into a negotiated contract with Vic Vera Builders, Inc. in the asphaltting of the streets in Don Juan Bayview, Sucat, Muntinlupa City.

APPROVED by the Sangguniang Panglungsod of Muntinlupa this 13th day of October 1997, on its 100th Regular Session.
