RESOLUTION AUTHORIZING MAYOR IGNACIO R. BUNYE TO ENTER INTO A SUPPLEMENTAL CONTRACT WITH ARKITEKT DESIGN MANAGEMENT DEVELOPMENT CORPORATION FOR THE COMPLETION OF ROAD CONSTRUCTION AND DRAINAGE SYSTEM IN BLOCKS 37-38, SOLDIERS HILLS, PUTATAN, MUNTINLUPA CITY.

WHEREAS, last June 6, 1996, the City Council passed and approved Ordinance No. 96-76, which provides for the construction of 140 linear meters of the road in Block 37-38, 40 meters for Block 32-33 and 40 meters for Block 33-36, Soldiers Hills. The construction of Block 37-38 covered only 1/2 of the street as shown in the attached map, Annex "A" of the said ordinance;

WHEREAS, pursuant to this Ordinance and based on the public bidding conducted, the City Council passed and approved Resolution No. 97-34 on May 29, 1997 allowing the City Mayor to enter into a construction Agreement with Arkitekt Design Management Development Corporation for the construction of the said road.

WHEREAS, on August 15, 1997, the contractor started the construction of the street in Blocks 32-33, 33-36 and 37-38;

WHEREAS, in the construction, of Blocks 37-38, the contractor could not start the development of the area because the portion of the street is elevated and the installation of a drainage system is needed.

WHEREAS, though no budget is yet allocated for the project, the contractor started to construct the drainage system and the half portion of the street.

WHEREAS, likewise, the other half portion of the street cannot be left uncompleted because it is also destroyed and the vehicles can hardly pass.

WHEREAS, the unit price of the project is the same as the on going project.


WHEREAS, the construction of the 250 meters street and the drainage system is advantageous to the City Government if done by the same contractor.

Bunye be allowed to enter into a supplemental contract with the **Arkitekt Design Management and Development Corporation** in the completion of the concreting and construction of the street and drainage system in **Blocks 37-38, Soldiers Hills, Putatan, Muntinlupa City.**




