NOW, THEREFORE, be it resolved as it is hereby resolved, that the City Council, in a session assembled grants to the City Mayor, Hon. Ignacio R. Bunye, authority to accept the donation over the pedestrian overpass across the Alabang-Zapote Road from the Alabang Commercial Corporation.
