WHEREAS, under Republic Act 7160 the Sangguniang Panglungsod is vested with the authority to grant franchise and enact ordinances authorizing the issuance of permit and licenses as well as impose taxes, fees and charges therefor;

WHEREAS, City Ordinance No. 97-24 states that every person, natural or juridical who wish to engage in the business of procuring and drawing of water within the City of Muntinlupa must secure a franchise for its operation;

WHEREAS, the same power is granted under Title 2, Article 20 of Ordinance 93-35, otherwise known as the Muntinlupa Revenue Code;

WHEREAS, DRILTECH SUPPLY, a corporation duly organized and doing business in the City of Muntinlupa with Principal address at Barangay Tunasan, City of Muntinlupa, has applied for a franchise under the same terms and conditions setforth in Ordinance No. 97-24;

WHEREAS, DRILTECH SUPPLY have successfully and satisfactorily complied with all the requirements provided for under Section 4 of the ordinance mentioned in the preceding paragraph;

NOW, THEREFORE BE IT RESOLVED, AS IT IS HEREBY RESOLVED, to grant franchise to DRILTECH SUPPLY to procure and or draw water in the City of Muntinlupa as per Ordinance No. 97-24.


