**Whereas, the F.S.A. Construction was awarded to construct the Two-Storey Multi-Purpose School Building, Phase I in Itaas Elementary School, NBP reservation, Poblacion, Muntinlupa City, per Resolution of the Pre-qualification, Bids and Awards Committee;**

**Whereas, the fund of P 700,000 allocated for this Phase I project came from the 1994 School Board Fund;**

**Whereas, from the 1995 School Board Fund a budget of P 890,504.89 was allocated for the continuation of the Phase II project;**

**Whereas, a negotiated contract was entered into between the City Government and the F.S.A. Construction for the continuation of the Phase II project;**

**Whereas, the F.S.A. Construction commenced the execution of the Phase II project from January 5, 1996 to February 28, 1996;**

**Whereas, after completion of the Phase II project, the F.S.A. Construction started the construction of the Phase III, and continued up to 80 % until May 1996 upon request of the principal of the school and City Engineer, despite that there was no budget yet available because the said Two-Storey Multi-Purpose School Building was going to be used for the school year 1996-1997;**

Whereas, on April 25, 1997 a budget of P 1,500,000.00 from the 1997 School Board fund was allocated for the completion of the Phase III project per certification issued by the Budget Office and Request for obligation of Allotment No. 221-9704052;

Whereas, on September 3, 1997 Mayor Ignacio Bunye in a letter addressed to Vice-Mayor Jaime Fresnedi requested for authority to enter into a Supplemental Agreement with the F.S.A. construction for the Completion of the Two-Storey Multi-Purpose Building, Phase III;

Resolve, therefore, as it is hereby Resolved, that Mayor Ignacio Bunyi be authorized to enter into a supplemental agreement with the F.S.A. Construction for the completion of the Two-Storey Multi-Purpose School Building, NBP Reservation, Poblacion, Muntinlupa City.
