WHEREAS, the contract of lease between the City Government of Muntinlupa and Mr. Reynaldo De Mesa, Owner/lessor of De Mesa Building expired last June 30, 1998;

WHEREAS, under the said contract of lease, the total leased area is 352 square meters;

WHEREAS, the new contract price was reduced from P40,000.00 to P20,000.00 per month. The reduction was granted by the LESSOR in order to help the City Government of Muntinlupa by reason of its financial difficulties;

WHEREAS, the continued use of De Mesa Building will ensure the public of undisrupted services for Sanitation, Division Office, B.H.W Office and Employees Clinic;

WHEREAS, the new contract price of De Mesa Building for P20,000.00 a month, is half the price cheaper as compared to the newly proposed commercial space recommended by Dr. Virgilio Abad;

RESOLVE, THEREFORE AS IT IS HEREBY RESOLVED, that the City Mayor, Hon. Jaime R. Fresnedi, be authorized to renew the contract between the City Government of Muntinlupa and Mr. Reynaldo De Mesa, owner/lessor of De Mesa Building (WENDY'S) at the reduced price of P20,000.00 per month, for one (1) year, from July 1, 1998 to June 30, 1999 which fund shall be taken from the approved budget of the Department of Health.
