WHEREAS, the City Government of Muntinlupa has a **Peoples' Law Enforcement Board (PLEB)** which was created on 21 October 1991 by then Sangguniang Bayan of Muntinlupa thru Kapasiyahan Bilang 91-224, as required by Memorandum Circular no. 91-002 issued by the **Department of Interior and Local Government (DILG)**.

WHEREAS, under *Section 4, Rule III* of the said circular, one of the composition of (PLEB) shall be any of the Sanggunian members chosen by them.

WHEREAS, the term of office of the members of the **People's Law Enforcement Board (PLEB)** shall be for a period of two (2) years from assumption of office. Such member shall hold office until his successor shall have been chosen and qualified;

WHEREAS, on 15 January 1996, the Sangguniang Panlungsod of Muntinlupa adopted Kapasiyahang Panlungsod Bilang 96-25, recommending Coun. Jo Jason T. Alcaraz as representative by the Sanggunian to the **People's Law Enforcement Board (PLEB)**;

WHEREAS, as of now, Coun. Jo Jason T. Alcaraz continue the assumption of his office;

WHEREAS, as **Coun. Jo Jason T. Alcaraz's** term of office had already expired and as a result of the previous Local Election held on **11 May 1998** there were new members elected and others were re-elected. Hence, it is incumbent upon the Sanggunian to choose and select from among themselves the councilor who will represent the Sanggunian in the **People's Law Enforcement Board (PLEB)**;


NOW, THEREFORE,
