WHEREAS, the Division of City Schools, City of Muntinlupa, was separated from the MUNTAPAT (Muntinlupa, Taguig, Pateros Division of City Schools) by virtue of an unnumbered memorandum signed by former Secretary Ricardo T. Gloria on 9 August 1996;

WHEREAS, the Sangguniang Panlungsod of Muntinlupa passed Kapasiyahang Panlungsod Bilang 97-15 dated 10 March 1997 requesting the 10<sup>th</sup> Congress thru Senators Vicente Sotto, Raul Roco and Rep. Manny Villar and DECS Secretary Ricardo T. Gloria to create the Division of City Schools in Muntinlupa City;

WHEREAS, the same resolution has not been acted upon by the 10<sup>th</sup> Congress;

WHEREAS, in order to provide legal status to the Division of City Schools, Muntinlupa City and in order to formalize the staffing pattern for the division, it is necessary that a bill be filed in the 11<sup>th</sup> Congress by our representative in Congress, Rep. Ignacio R. Bunye, creating the said division;

WHEREAS, there is an overwhelming support from both public and private schools to create a Division of City Schools in Muntinlupa City;

WHEREAS, by having our own division, policies, programs, projects and other activities for the welfare of our educational sector can be initiated and implemented at our level without having to get prior approval and authority from MUNTAPAT Division of City Schools;
