A RESOLUTION AUTHORIZING MAYOR IGNACIO R. BUNYE TO ENTER INTO A NEGOTIATED CONTRACT WITH THE A. P. MELENDREZ CONSTRUCTION IN THE CONSTRUCTION OF THE TWO-STOREY TUNASAN HEALTH CENTER, PHASE II, MUNTINLUPA CITY.

WHEREAS, the National Government, thru the Urban Health and Nutrition Program, Project Management Office, Department of Health, allocated an amount of One Million Fifty Thousand Pesos (P1,050,000.00) for the construction of the Tunasan Health Center, in Barangay Tunasan, Muntinlupa City;

WHEREAS, on November 29, 1996, a public bidding was conducted and that the A. P. Melendrez Construction won the bid per Resolution of the Pre-qualification, Bid and Awards Committee;

WHEREAS, the City Council approved Kapasiyahang Panglungsod Bilang 97-05, granting the City Mayor authority to enter into a contract with the A. P. Melendrez Construction in the construction of the Tunasan Health Center, Phase I;

WHEREAS, the public bidding on November 29, 1996 was only for the Phase I project, because the project Management Office, Department of Health, allocated only One Million Fifty Thousand Pesos (P1,050,000.00), Phase II has no budget allocated;

WHEREAS, the City Government cannot leave the project unfinished, as the same (health center) cannot be use and that Barangay Tunasan is only renting for its health center in Buendia Street. So, a fund of Two Million Two Hundred Seventy Thousand Two Hundred Twenty Seven Pesos and 11/100 (P2,270,227.11) is allocated for the immediate completion of the Phase II project;

WHEREAS, the amount of Two Million Two Hundred Seventy Thousand Two Hundred Twenty Seven Pesos and 11/100 (P2,270,227.11) shall be taken from the unreleased fund of P120 Million PNB Loan per Certification of the Budget Office, Treasurer's Office and City Accountant's Office dated December 7, 1997;
