A RESOLUTION GRANTING THE CITY GOVERNMENT OF MUNTINLUPA, REPRESENTED BY HONORABLE MAYOR JAIME R. FRESNEDI, THE AUTHORITY TO ENTER INTO A NEGOTIATED CONTRACT WITH VIC VERA BUILDERS, INC., FOR THE ADDITIONAL WORKS OF THE PROJECT ROAD WIDENING LOCATED AT THE SOUTHERN PORTION OF MONTILLANO ST., FROM ALABANG VIADUCT TO THE NATIONAL ROAD.

WHEREAS, the construction of the Project (ROAD WIDENING OF MONTILLANO STREET) is one of the priorities of the City Government of Muntinlupa;

WHEREAS, on 8 November 1997, the Notice of Award was given to the contractor (VIC VERA BUILDERS, INC) after the Sanggunian Panlungsod passed Resolution No. 97-66 giving the then City Mayor Ignacio R. Bunye the authority to enter into a Contract;

WHEREAS, as the construction of the Project was being implemented different problems were encountered, such as the following:

1. Demolition of existing concrete frontage of different establishment
2. Additional Pipe laying
3. Restoration Works
4. Construction of Ramps

WHEREAS, the amount of the said additional works is One Million Three Hundred Ninety Five Thousand, Five Hundred Sixty Nine Pesos and Thirteen Centavos (P1,395,569.13) covering the Southern portion of Montillano Street, from Alabang Viaduct to the National Railroad, as per Bill of Materials prepared by the City Engineer's Office and approved by the City Mayor;

WHEREAS, the budget allocated for the said Additional Works was taken from the Infrastructure Funds – Capital Outlay, as per Request for Obligation of Allotment No. 1019804-0568;

WHEREAS, actual commencement of the project was made on 11 February 1998 having a duration of 120 days, said project plus the additional works were finally completed on 12 March 1998;

WHEREAS, the aforecited additional works were not included in the previous contract awarded to the contractor;

WHEREAS, the award of the said additional works is in accordance with the previous contract under Article VII, entitled Variation Order/Change Order/ Additional Works, and under the Government Accounting and Auditing Manual;

NOW, THEREFORE,

BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the *Sangguniang Panlungsod of Muntinlupa*, to grant the City Government of Muntinlupa represented by Hon. Mayor Jaime R. Fresnedi the authority to enter into a negotiated contract with VIC VERA BUILDERS INC., for the additional works of the project (ROAD WIDENING, VARIATION ORDER NO. I) amounting to One Million Three Hundred Ninety Five Thousand Five Hundred Sixty Nine Pesos and 13/100 (P1,395,569.13) to be taken from the 1998 Executive Budget, Capital Outlay - Infrastructure Fund.

ADOPTED, by the *Sangguniang Panlungsod of Muntinlupa* this 5th day of October 1998, on its 13 Regular Session.




