WHEREAS, per Certification and Request For Obligation of Allotment No. 221-9806-144 there is a budget of Six Hundred Ninety Eight Thousand Eight Hundred Ninety Four Pesos (P 698,894.00) from the 1998 School Board Fund, Capital Outlay;

WHEREAS, per resolution No. 98-06 of the PBAC the project was awarded to the P.D.J. Integrated Construction because it won the public bidding on August 26, 1998 with the lowest bid price of P 767,800.00;

RESOLVE, THEREFORE, AS IT IS HEREBY RESOLVED, that Mayor Jaime R. Fresnedi be authorized to enter into a contract with P.D.J. Integrated Construction for the project, Installation of Service Entrance, Muntinlupa National High School, NBP Reservation, Muntinlupa City.






