WHEREAS, per Resolution No. 98-21 of the PBAC, the project was awarded to Aesthetic Construction and Trading because it won the public bidding on September 29, 1998 with the lowest bid price of **One Million Nine Hundred Ninety Thousand Five Hundred Sixty Five Pesos (P1,990,565.00);**

WHEREAS, the Approved Agency Estimate of the Project is **One Million Nine Hundred Ninety Three Thousand Three Hundred Eighty Eight 48/100 Pesos (P 1,993,388.48)** and the Allowable Government Estimate is **Two Million Six Thousand Eight Hundred Thirty Four Pesos (P2,006,834.00),** respectively;

RESOLVE, THEREFORE, AS IT IS HEREBY RESOLVED, that Mayor Jaime R. Fresnedi be authorized to enter into a contract with the Aesthetic Construction and Trading for the **Renovation and Furnishing of the Superintendent and Principal's Office, Muntinlupa Central Elementary School, Poblacion, Muntinlupa City.**
