WHEREAS, per Bill of Materials the cost of the project is **Four Million Three Hundred Fifteen Thousand and Nine Pesos (P 4,315,009.00)**;

WHEREAS, per Certification and Request For Obligation of Allotment No. 101 9808-0448 there is a budget of **Four Million Three Hundred Fifteen Thousand and Nine Pesos (P 4,315,009.00)** allocated for the project from the Community Development Fund, 1998 Executive Budget;

WHEREAS, the Approved Agency Estimate of the project is **Four Million Three Hundred Fifteen Thousand Nine and 69/100 Pesos (P 4,315,009.69)** and the Allowable Government Estimate is **Four Million Six Hundred Seventeen Thousand and Fifty Four Pesos (P 4,617,054.00)**;

RESOLVE, THEREFORE, AS IT IS HEREBY RESOLVED, that Mayor Jaime R. Fresnedi be authorized to enter into a contract with M.D.L. Resort Constructors, Inc. for the project, Road Concreting (Phase I), Soldiers Hills, Putatan, Muntinlupa City.

ADOPTED, by the *Sangguniang Panlungsod* of Muntinlupa this 12th day of October 1998, on its 14th Regular Session








