WHEREAS, one of the priority projects of the City Government is the concreting of the streets in Villa Carolina I, Tunasan, Muntinlupa City;

WHEREAS, per Bill of Materials the cost of the project is Two Million Nine Hundred Ninety Five Thousand Pesos (P 2,995,000.00);

WHEREAS, per Certification and Request For Obligation of Allotment No. 1019808-0449 there is a budget of Three Million Pesos (P 3,000,000.00) allocated for the project from the Community Development Fund, 1998 Executive Budget;

WHEREAS, per Resolution No. 98-02 of the PBAC the project was awarded to AM-FM Builders because it won the public Bidding on August 26, 1998 with the lowest bid price of Two Million Nine Hundred Ninety Five Thousand Pesos (P2,995,000.00).

WHEREAS, the Approved Agency Estimate of the project is Two Million Nine Hundred Ninety Nine Thousand Two Hundred Sixty Seven and 42/100 Pesos (P 2,999,267.42) and the Allowable Government Estimate is Two Million Nine Hundred Ninety Eight Thousand Four Hundred Sixty Seven Pesos (P 2,998,467.00);

RESOLVE, THEREFORE, AS IT IS HEREBY RESOLVED, that Mayor Jaime R. Fresnedi be authorized to enter into a contract with AM-FM Builders, for the Project, Concreting of Dollar St., Villa Carolina I, Tunasan, Muntinlupa City.




