WHEREAS, per Resolution No. 98-09 of the PBAC the project was awarded to VIC VERA Builders, Inc. because it won the public bidding on August 26,1998 with the lowest bid price of One Million Nine Hundred Fifty Thousand Pesos (P 1,950,000.00);

WHEREAS, the Approved Agency Estimate of the Project is One Million Six Hundred Forty Eight Thousand Nine Hundred Forty Two Pesos and 85/100 (P1,648,942.85) and the Allowable Government Estimate is One Million Eight Hundred Five Thousand Four Hundred Seventy One Pesos and 422/100 (P1,805,471.42);
