WHEREAS, the City Council approved Ordinance No. 97-34 allocating the amount of One Million Two Hundred Thousand Pesos (P1,200,000.00) for the project;

WHEREAS, there is a certification that said fund is available;

RESOLVE, THEREFORE, AS IT IS HEREBY RESOLVED, that Mayor Ignacio R. Bunye be authorized to enter into a negotiated contract with A.P. Melendrez Construction in the Construction of Drainage and Sidewalk in Lower Sucat, Muntinlupa City.




