WHEREAS, per Bill of Materials the cost of the Project is Nine Hundred Eighty Six Thousand Fifty Seven Pesos (P 986,057.00);

WHEREAS, per Certification and Request For Obligation of Allotment No. 1019808-0450 there is a budget of One Million Pesos (P 1,000,000.00) allocated for the project from the Community Development Fund 1998 Executive Budget;

WHEREAS, the Approved Agency Estimate for the project is Nine Hundred Eighty Six Thousand Fifty Seven Pesos and 90/100 (P 986,057.90) and the Allowable Government Estimate is One Million Fifty Thousand One Hundred Ninety Five Pesos (P1,050,195.00) respectively;

RESOLVE, THEREFORE, AS IT IS HEREBY RESOLVED, that Mayor Jaime R. Fresnedi be authorized to enter into a contract with AM-FM Builders, Inc., for the Project, Road Concreting of Bendix St., Liberty Homes, Cupang, Muntinlupa City,
