WHEREAS, one of the priority projects of the City Government is the **Concreting of Elias St., Alabang, Muntinlupa City;**

WHEREAS, per Bill of Materials the cost of the project is **Nine Hundred Ninety Five Thousand Pesos (P 995,000.00);**

WHEREAS, per Certification and Request for Obligation of Allotment No. 1019808-0451 there is a budget of **One Million Pesos (P 1,000,000.00)** allocated for the project from the Community Development Fund, 1998 Executive Budget;

WHEREAS, per Resolution No. 98-07 of the PBAC the project was awarded to P. D. J. Integrated Construction because it won the public bidding on August 26, 1998 with the lowest bid price of **Nine Hundred Ninety Five Thousand Pesos (P 995,000.00);**

WHEREAS, the Approved Agency Estimate of the project is **Nine Hundred Eighty Nine Thousand Three Hundred Twenty One Pesos and 72/100 (P989,321.72)** and the Allowable Government Estimate is **One Million Twelve Thousand One Hundred Sixty Pesos and 86/100 (P 1,012,160.86)** respectively;

RESOLVE, THEREFOR, AS IT IS HEREBY RESOLVED, that Mayor Jaime R. Fresnedi be authorized to enter into a contract with P. D. J. Integrated Construction for the Project, **Concreting of Elias St., Alabang, Muntinlupa City.**
