WHEREAS, the City of Muntinlupa is presently experiencing the devastation wrought by Typhoon "Loleng" and continues to experience the same, causing massive flood and destruction to properties in many areas,

WHEREAS, as per report from the Local Disaster Coordinating Council, Social Services Department, the Barangay Councils and their respective Chairs and field reports from the people themselves, the typhoon has already flooded low-lying areas, the lakeside shorelines, creeksides and other low-lying areas, especially the so-called depressed communities;

WHEREAS, the massive flooding of these areas have caused untold miseries to thousands of people who have to be relocated to safer areas like the public elementary schools which now serve as evacuation centers;

WHEREAS, in view of the dislocation of the affected people in different barangays, there is an imperative need for the City government to immediately respond to the crisis by providing basic services to the affected people, aside from the rescue and relief operations now being done;

WHEREAS, in order to carry out the immediate assistance to the affected families, as well as to prevent any further damage and loss to life and property, there is an imperative and urgent need to declare Muntinlupa City in a State of Calamity and authorizing the immediate release of calamity funds and for other purposes;
