WHEREAS, the typhoons and heavy rains are causing floods, placing thousands of houses along the river banks, creeks and Laguna de Bay under water and destroying roads and building and houses;

WHEREAS, the need for food and medicines are also increasing because there are so many people especially children who are getting hungry and suffering from various kinds of illness;

WHEREAS, there are so many residents of Muntinlupa affected by the floods who have evacuated to safe areas. These evacuees need food, medicines and other assistance;

WHEREAS, in view of the urgency of this situation and in order to be ready to help and protect the people affected by the La Nina phenomenon, it is imperative to have a stand-by loan of P5,000,000.00 available at anytime.

RESOLVE, THEREFORE, AS IT IS HEREBY RESOLVED, that Mayor Jaime R. Fresnedi be authorized to secure as stand-by loan of Five Million Pesos (P5,000,000.00) in preparation for the La Nina phenomenon.
