WHEREAS, per Bill of Materials the cost of the Project is Two Million Four Hundred Forty Three Thousand Ninety Six Pesos (P2,443,096.00);

WHEREAS, per Certification and Request for Obligation and Allotment No. 1019808-0446 there is a budget of Two Million Four Hundred Forty Three Thousand Ninety Six 90/100 (P2,443,096.90) allocated for the project from the Community Development Fund (CDF) 1998 Executive Budget;

WHEREAS, per Resolution No. 98-05 of the PBAC, the project was awarded to MIX CONSTRUCT because it won the Public Bidding held on August 26, 1998 with the lowest price of Two Million Four Hundred Three Thousand Ninety Six Pesos (P2,443,096.00);

WHEREAS, the Approved Agency Estimate (AAE) for the project is Two Million Four Hundred Forty Three Thousand Ninety Six Pesos and Ninety Centavos (P2,443,096.90) and the Allowable Government Estimate (AGE) is Two Million Five Hundred Ninety Nine Thousand Seven Hundred Seventy One Pesos and Eight Centavos (P2,599,771.08), respectively;

RESOLVE, THEREFORE, AS IT IS HEREBY RESOLVED, that City Mayor, Hon. Jaime R. Fresnedi be authorized to enter into a contract with Mix Construct for the project Street Lighting of Susana Heights located at Tunasan,
