WHEREAS, the San Simon Neighborhood Association, Inc., substantially met the requirements for accreditation provided for under the Local Government Code;

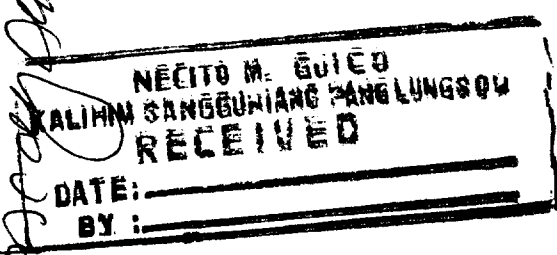
