WHEREAS, per Bill of Materials the costs of the Project is Three Hundred Eleven Thousand Two Hundred Sixty Two Pesos & 99/100 (P311,262.99);

WHEREAS, per Certification and Request for Obligation and Allotment No. 1019808-0438 there is a budget of P340,000.00 allocated for the project from the Community Development Fund (CDF) 1998 Executive Budget;

WHEREAS, per Resolution No. 98-19 of the PBAC the project was awarded to Rossa Builder because it won the Public Bidding Held on August 26, 1998 with the lowest bid price Three Hundred Thirty Seven Thousand Two Hundred Eighteen Pesos (P337,218.00);

WHEREAS, the Approved Agency Estimate (AAE) for the project is Three Hundred Eleven Thousand Two Hundred Sixty Two Pesos & 99/100 (P311,262.99) and the Allowable Government Estimate (AGE) is Three Hundred Thirty Seven Thousand Two Hundred Eighteen Pesos & 18/100 (P337,218.18) respectively;

RESOLVE, THEREFORE, AS IT IS HEREBY RESOLVED, that Mayor Jaime R. Fresnedi be authorized to enter into a contract with Rossa Builder for the project concreting of parking area in City Hall Annex, located at National Road, Putatan, Muntinlupa City;
