WHEREAS, one of the priority projects of the City Government is the Lighting of Alabang Viaduct located at Alabang, Muntinlupa City;

WHEREAS, per Bill of Materials the cost of the Project is Two Million Seventy Five Thousand Three Hundred Sixty Eight and Twenty Centavos (P2,075,368.20);

WHEREAS, per Certification and Request for Obligation of Allotment No. 1019808-0452 there is a budget of Two Million, Five Hundred Thousand Pesos (P2,500,000.00) allocated for the project from the Community Development Fund (CDF)1998 Executive Budget;

WHEREAS, per Resolution No. 98-08 of the PBAC the project was awarded to R.N De Leon Construction because it won the public bidding held on August 26, 1998 with the lowest bid price of Two Million Two Hundred Thirty One Thousand Twenty Pesos (P2,231,020.00).

WHEREAS, the Approved Agency Estimate (AAE) for the projects is Two Million Seventy Five Thousand Three Hundred Sixty Eight Pesos and Twenty Centavos (P2,075,368.20) and the Allowable Government Estimate (AGE) is Two Million Two Hundred thirty Six Thousand Two Hundred Nine Pesos and Twenty Two Centavos (P2,236,209.22) respectively;

RESOLVE, THEREFORE, AS IT IS HEREBY RESOLVED, that Mayor Jaime R. Fresnedi be authorized to enter into a contract with R.N De Leon Construction for the project lighting of Alabang Viaduct located at Alabang, Muntinlupa City.
