WHEREAS, Section 80 of the *Local Government Code of 1991* and, Art. 167 of its *Implementing Rules and Regulations*, provided for the creation of a *Personnel Selection and Promotion Board*;

WHEREAS, pursuant to above quoted laws, said *Personnel Selection and Promotion Board* shall be composed of the City Mayor or his duly authorized representative as Chairman and members thereof shall be determined by the Sangguniang Panglungsod, in accordance with pertinent civil service law, rules and regulations;

WHEREAS, the *Personnel Selection Board* shall formulate screening procedures and shall adopt criteria for evaluating candidates for employment of promotions in the first and second levels of City Government Career Service;

WHEREAS, the *Personnel Selection Board* shall formulate policies on employee welfare in accordance with civil service law, rules and regulations. A representative of *Civil Service Commission*, if any, and the *Local Human Resource Management Officer* shall be *ex-officio* member;
