WHEREAS, the PROJECT (Construction of Two-Storey Six-Classroom School Building, Phase II) located at Putatan Elementary School is one of the priorities of the City Goevernment;

WHEREAS, the estimated cost (Approved Agency Estimate) of the project is One Million Five Hundred Fifty Three Thousand Five Hundred Twenty Pesos (P1,553,520.00) and there is a budget allocated in the amount of One Million Seven Hundred Thousand Pesos (P 1,700,000.00) to be taken from the 1997 School Board Fund Capital Outlay, Unfinished School Building per Certification and Request for Obligation and Allotment No. 221-9712-60;

WHEREAS, a public bidding was conducted on January 20, 1998 and the Sellihca Construction won the bid with a bid price of One Million Eight Hundred Thirty Thousand Pesos (P1,830,000.00);

WHEREAS, the Allowable Government Estimate for the PROJECT is One Million Six Hundred Ninety Five Thousand Nine Hundred Ninety Nine Pesos and 21/100 (P1,695,999.21);

**RESOLVE, THEREFORE, AS IT IS HEREBY RESOLVED,** that the Hon. City Mayor Ignacio R. Bunye be authorized to enter int a contract with the Sellihca Construction in the amount of One Million Six Hundred Ninety Five Thousand Nine Hundred Ninety Nine Pesos and 21/100;
