WHEREAS, the construction of the PROJECT (PROPOSED COVERED COURT) located at Alabang Elementary School is one of the priorities of the City Government;

WHEREAS, the estimated cost (Approved Agency Estimate) of the project is Five Million Eight Hundred Ninety Thousand and Five Pesos (P5,890,005.00) and there is a budget allocated in the amount of Six Million Pesos (P6,000,000.00) to be taken from the Special Education Fund, Development Project per Certification and Request for Obligation and Allotment No. 221-9716-186;

WHEREAS, a public bidding was conducted on January 20, 1998 and the JEG Builders won the bid with a bid price of Six Million Seventy Three Thousand and Forty Five Pesos (P6,073,045.00)

WHEREAS, the Allowable Government Estimate for the PROJECT is Six Million Fourty Eight Thousand Two Hundred Fifty Eight Pesos and 96/100 (P6,048,258.96);

RESOLVE, THEREFORE, AS IT IS HEREBY RESOLVED, that the Hon. City Mayor Ignacio R. Bunye be authorized to enter into a contract with the JEG Builders for the construction of covered court in the amount of Six Million Pesos (P6,000,000.00).






