WHEREAS, the PROJECT, Construction of Three-Storey Fifteen-Classroom School Building, Phase II, located at Alabang Elementary School is one of the priorities of the City Government;

WHEREAS, the estimated cost of the project is Six Million Two Hundred Twenty Four Thousand One Hundred Thirteen Pesos and 85/100 (P6,224,113.85) and there is a budget allocated in the amount of Seven Million Pesos (P7,000,000.00) to be taken from the Special Educational Fund, Capital Outlay per Certification and Request for Obligation and Allotment No. 221-9711-185;

WHEREAS, a public bidding was conducted on January 20, 1998 and the MDL Resort Constructors, Inc., won the bid with a bid price of Six Million Seven Hundred Fifty Four Thousand Pesos (P6,754,000.00);

WHEREAS, the Approved Agency Estimate of the Project is Six Million Two Hundred Twenty Four Thousand One Hundred Thirteen Pesos and 85/100 (P6,224,113.85) and the Allowable Government Estimate is Six Million Seven Hundred Fifty Four Thousand Nine Hundred Forty Nine Pesos and 04/100 (P6,754,949.04);

RESOLVE, THEREFORE, AS IT IS HEREBY RESOLVED, that the Hon. City Mayor Ignacio R. Bunye be authorized to enter into a contract with the MDL RESORT CONSTRUCTORS, INC.
