WHEREAS, the Approved Agency Estimate of the Project is Five Hundred Fifty Three Thousand One Hundred Forty Seven Pesos and 97/100 (P553,147.97);

RESOLVE, THEREFORE, AS IT IS HEREBY RESOLVED, that the Hon. City Mayor Ignacio R. Bunye be authorized to enter into a contract with the R.Q.N. Construction for the construction of Additional Second (2nd) Floor, Family Planning Building in the amount of Five Hundred Fifty Three Thousand One Hundred Forty Two Pesos and 97/100 (P553,142.97);
