WHEREAS, the estimated cost of the project is Five Hundred Fifty Three Thousand One Hundred Forty Seven Pesos and 97/100 (P553,147.97) and there is a budget allocated in the amount of Five Hundred Fifty Three Thousand One Hundred Forty Three Pesos (P553,143.00) to be taken from the LPP Support Fund, DOH - National, per Certification and Request for Obligation of Allotment No. 101-697120330;

WHEREAS, a public bidding was conducted on January 20, 1998 and the R.Q.N. Construction won the bid with a bid price of Five Hundred Fifty Three Thousand One Hundred Forty Two Pesos and 97/100 (P553,142.97);

WHEREAS, the Approved Agency Estimate of the Project is Five Hundred Fifty Three Thousand One Hundred Forty Seven Pesos and 97/100 (P553,147.97);

RESOLVE, THEREFORE, AS IT IS HEREBY RESOLVED, that the Hon. City Mayor Ignacio R. Bunye be authorized to enter into a contract with the R.Q.N. Construction for the construction of Additional Second (2<sup>nd</sup>) Floor, Family Planning Building in the amount of Five Hundred Fifty Three Thousand One Hundred Forty Two Pesos and 97/100 (P553,142.97);
