A RESOLUTION CREATING A TASK FORCE TO CONDUCT AN IN DEPTH STUDY ON THE CAUSE OR CAUSES OF GROUND/LAND SUBSIDENCE AND FAULT LINES IN THE CITY OF MUNTINLUPA, DEFINING ITS DUTIES AND RESPONSIBILITIES, AND FOR OTHER PURPOSES.

WHEREAS, the occurrence of ground/land subsidence and fault lines in the City of Muntinlupa is very alarming;

WHEREAS, such occurrence has spawned a lot of speculations and guesses as to the cause or causes of ground/land subsidence and fault lines in the City of Muntinlupa, including the alleged excessive withdrawal and utilization of subterranean and/or ground water for commercial and other purposes;

WHEREAS, there is an urgent need to conduct an in depth study on this occurrence which is a new phenomenon never before experienced by the City of Muntinlupa to avoid further speculations and baseless accusations by determining once and for all the real cause or causes of ground/land subsidence and fault lines in our lines;

WHEREAS, in order to protect the inhabitants of the city and their properties from the harmful effects of ground/land subsidence and fault lines it is imperative that a Task Force be immediately formed for the aforementioned purposes and to recommend remedial measures to cushion the impact of such occurrence, including proposed solutions, if possible under the circumstances;

WHEREAS, in view of this new phenomenon, there is a need to involve other agencies and other sectors of the community to provide the Task Force with the much needed technical expertise and competence in the determination of the cause or causes of such occurrence;

WHEREAS, the *Task Force* shall be composed of representatives from the local government, selected national government agencies, and non-government organizations, to, wit:

1. Sangguniang Panlungsod – as Chairman of Task Force
2. Muntinlupa Disaster Coordinating Council
3. City Engineering Department
4. A.B.C. President
5. DOST – PHILVOCS
6. Mines and Geo-Sciences Bureau
7. National Water Resources Board
8. Muntinlupa Chamber of Commerce and Industry (MCCI) President
9. Urban Poor

WHEREAS, the *Task Force* shall have the following duties and responsibilities to wit:

1. Conduct an in depth study of the cause of ground/land subsidence and fault lines in the City of Muntinlupa;
2. Meet regularly from time to time;
3. Use local government facilities, personnel and other needs in the conduct of the in depth study;
4. Coordinate with one another and assist members in the performance of their respective tasks;
5. Submit its report to the Office of the Mayor and the Sangguniang Panlungsod, containing therein its findings and recommendations, within three months from the passage of its resolution;
6. Perform such other duties and responsibilities as may be necessary under the circumstances.

WHEREAS, in order for the *Task Force* to effectively perform its duties and responsibilities, the office of the Mayor is hereby authorize to utilize, as may be necessary, appropriation under the calamity fund for the aforecited purposes;

NOW, THEREFORE,

BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that a resolution be passed creating a *Task Force* to conduct an in depth study on the cause or causes of ground/land subsidence and fault lines in the City of Muntinlupa, defining its duties and responsibilities, and for other purposes.
