– Duties and Responsibilities:

- Develop a long-term, comprehensive Waste Management Plan that will ensure long-term, effective ecological management of various wastes.
- Integrate various waste management and reduction scheme and strategies of the Barangay in its area of jurisdiction.
- Coordinate and conduct consultative meetings with different sectors of the community (e.g. schools, market, subdivision, and industrial.)
- Review and recommend resolution and or ordinance that will ensure enforcement and implementation of its program.
- The board shall meet at least once a month.

Section IV – EFFECTIVITY, this resolution shall take effect upon its approval.






