RESOLUTION NO. 99-066

A RESOLUTION EXPRESSING OPPOSITION TO THE SUDDEN INCREASE IN TOLL RATES IMPOSED BY THE PHILIPPINE NATIONAL CONSTRUCTION CORPORATION (PNCC) AND CALLING FOR A ROLLBACK OF TOLL FEES TO ITS PREVIOUS RATES UNTIL PRIOR PUBLIC HEARINGS ARE CONDUCTED.

WHEREAS, the Philippine National Construction Corporation (PNCC) has increased the toll rates by an average of Five Hundred Percent (500%) in the South Luzon Tollways (Alabang-Bicutan portion);

WHEREAS, in the Alabang to Sucat portion alone, the increase is a whopping 1,200% (from P.50 centavos to P6.00);

WHEREAS, the sudden increase was made without even conducting prior public hearings which is an elementary requirement of due process as guaranteed by the Constitution;

WHEREAS, the increase is so high that it would adversely affect thousands of motorists, including residents of Muntinlupa City, in these times of economic difficulties;

WHEREAS, His Excellency President Joseph E. Estrada has ordered the suspension of the imposition of the new toll fees on February 17, 1999 and directed DPWH Secretary Gregorio Vigilar, concurrent Chair of the Toll Regulatory Board, to look into the matter together with PNCC and Citra Metro Manila Tollways Corporation;

WHEREAS, despite said order, PNCC has continued and still continues to collect the new toll rates imposed on the users of the South Luzon Tollways;
