WHEREAS, the Prosecutors' Office has been renting the *Doña Zoila Building* located at the National Road, Putatan, Muntinlupa City since *June 1, 1996* up to the present;

WHEREAS, the total area being used by the Prosecutors' Office is 250 square meters and the monthly rental is **P50,000.00**;

WHEREAS, the budget of the Prosecutors' Office in the 1999 Executive Budget that can be used for the rental is P420,000.00;

WHEREAS, the balance of P 380,000.00 shall be paid next year, 2000, and such amount shall be provided for in the Executive Budget for 2000;

WHEREAS, the lease contract shall be for one (1) year, from January 1, 1999 to December 31, 1999.

RESOLVED, THEREFORE, AS IT IS HEREBY RESOLVED, that the City Mayor Jaime Fresnedi be allowed to enter into a contract of lease with *Mrs. Conchita V. Recaido* for the use of the *Doña Zoila Building* by the Prosecutors' Office for one (1) year from January 1, 1999 to December 31, 1999 at P50,000.00 per month.
