WHEREAS, on June 17, 1996, the City Council passed and approved Resolution No. 96-23 authorizing Mayor Ignacio R. Bunye to hire a qualified person/entity to make a comprehensive development plan of the five (5) hectares lot in Alabang Stock Farm allotted as government center for the City of Muntinlupa;

WHEREAS, pursuant to this Resolution, the City Mayor hired Palafox Associates;

WHEREAS, Resolution No. 97-12 was also passed and approved by the City Council, stating that:

"NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod to approve the resolution of the Technical Committee of the Pre-qualification, Bids and Awards Committee declaring a failure of bidding, and for the City Mayor to negotiate with Palafox and Associates for the submission of the Master Plan for the Civic Center and enter into a contract under such terms and conditions as will be beneficial and advantageous to the government, subject to review and ratification of the contract by the Sangguniang Panlungsod pursuant to the provision of RA 7160."






