**WHEREAS, the City of Muntinlupa, a highly-urbanized city in Metro Manila, needs to strengthen its linkage** with other local government units, particularly in other regions of the country;

**WHEREAS, the City of Muntinlupa expresses its intention** to establish a sisterhood program with the Municipality of Sapián, Capiz;

**WHEREAS, the Municipality of Sapián, through its Hon. Mayor Remedios O. Oñas, has already expressed its similar intention** to forge the sisterhood program;

**NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED,** that a resolution be passed *expressing our intention to establish a sisterhood program* with the Municipality of Sapián, in the province of Capiz.

**RESOLVED, FURTHER,** that copies of this resolution *be furnished Hon. Mayor Remedios O. Oñas, Municipal Mayor, Sapián, Capiz and the Sangguniang Bayan of the same Municipality* for their information and perusal.

**ADOPTED,** by the *Sangguniang Panglungsod of Muntinlupa* this 21<sup>st</sup> day of July 1999 on its 47<sup>th</sup> Regular Session.




