WHEREAS, in view of the affected people in different barangays, and damaged roads in certain areas there is an imperative need for the City Government to immediately respond to the crisis by providing basic services to the affected people, aside from the rescue and relief operations now being done;

WHEREAS, to carry out the immediate assistance to the affected families as well as to prevent any further damage and loss to life and property there is a need to declare Muntintupa City as in a State of Calamity and to authorize the immediate release of calamity funds and for other purposes;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, to declare Muntiniupa City as in a State of Calamity and to authorize the immediate release of calamity funds for the following purposes:

For the purchase of foods, medicines and other necessary supplies/ materials as may be needed from time to time by affected individuals.
