WHEREAS, the City of Muntinlupa is presently experiencing the continuous heavy rains *causing massive floods and damage to roads and to properties* in many areas:

WHEREAS, as per report from the Local Disaster Coordinating Council, Social Services Department, the Barangay Councils and their respective Chairs and field reports from the people themselves, *the heavy rains have already flooded* the shorelines, creek sides, and other low-lying areas especially the so-called depressed communities;

WHEREAS, in view of the affected people in different barangays, and damaged roads in certain areas *there is an imperative need for the City Government to immediately respond* to the crisis by providing basic services to the affected people, aside from the rescue and relief operations now being done;

WHEREAS, to carry out the immediate assistance to the affected families as well as to prevent any further damage and loss to life and property *there is a need to declare Muntinlupa City as in a State of Calamity and to authorize the immediate release of calamity funds* and for other purposes;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, to declare Muntinlupa City as in a State of Calamity and to authorize the immediate release of calamity funds for the following purposes:

1. For the purchase of foods, medicines and other necessary supplies/materials as may be needed from time to time by affected individuals.


