WHEREAS, there is a need to interconnect this Daang Hari Road to the main road of Katarungan Village and road network of Victoria Homes to decongest the heavy vehicular traffic in the National Road of Poblacion and Alabang, Muntinlupa City;

WHEREAS, interconnecting the Daang Hari road to the Katarungan Village and Victoria will be of great help to the residents of the said villages including Ridgeview Homes and other neighboring areas;

RESOLVE, therefore, as it is hereby RESOLVED, to request the Department of Public Works and Highways, National Capital Region to interconnect the Daang Hari road to the main road of Katarungan Village and road network of Victoria Homes;

RESOLVE, further as it is hereby RESOLVED, that the DPWH, National Capital Region be furnished with a copy of this Resolution.
