WHEREAS, on September 22, 1999 the Department of Justice (DOJ) through the Director of the New Bilibid Prisons has effected the demolition of houses of families at Sitio Mapalad, Camp Sampaguita Muntinlupa City;

WHEREAS, that the said demolition is contrary to the policy of the national government on "no demolition without relocation" which is also the ideals of the Chief, Executive, His Excellency President Joseph Ejercito Estrada;

the demolition was undertaken in the area not considered as WHEREAS, danger zones as defined by law;

NOW THEREFORE, RESOLVE AS IT IS HEREBY RESOLVED by the Sangguniang Panlungsod of Muntinlupa to request the Honorable Serafin Cuevas Secretary of the Department of Justice (DOJ), to stop the demolition of the houses of the families located at Sitio Mapalad, Camp Sampaguita, New Bilibid Prisons (NBP), Muntinlupa City pending their relocation;

RESOLVE FURTHER, that copies of this resolution be furnished His Excellency President Joseph Ejercito Estrada, President of the Republic of the Philippines, the Philippine Congress, and the Director National Penitentiary, Muntinlupa City.

ADOPTED, by the Sangguniang Panlungsod of Muntinlupa this 22nd day of September 1999, on its 55th Regular Session.
