WHEREAS, The Sangguniang Panlungsod opposed the sudden increase in toll rates imposed by Philippine National Construction Corporation through Resolution No. 99-066 on February 23, 1999;

WHEREAS, a copy of the said resolution was furnished to the management of Philippine National Construction Corporation but was simply ignored and instead another sudden increase was imposed on October 10, 1999;

WHEREAS, that the October 10, 1999 toll rates hike was implemented without the required legal notices and while the said issue was still pending with the Toll Regulatory Board for disposition;

WHEREAS, residents of Muntinlupa and its neighboring municipalities and cities are greatly affected by the said toll rates hike;

NOW, THEREFORE, BE IT RESOLVED, that the increase in toll rates imposed by the Philippine National Construction Corporation last October 10, 1999 be strongly opposed and call for a roll back of toll fees to its previous rates until prior public hearings are conducted.

RESOLVED, FURTHER, that the Philippine National Construction Corporation be furnished a copy of this resolution.
