WHEREAS, Section 16 of the New Local Government Code of 1991 prescribes that: "Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdiction, local government units shall ensure and support among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants."

WHEREAS, the Sangguniang Panlungsod has passed and approved several ordinances prescribing rules and regulations for traffic, sanitation, public safety and public health and other related ordinances, and imposing penalties for violations thereof,

WHEREAS, when said ordinances were passed, there were no provisions for the printing and issuance of citation tickets for violators of the said ordinances;

WHEREAS, in order to ensure effective implementation of the said ordinances,

there is a need to print and issue citation tickets;

NOW, THEREFORE, BE IT RESOLVED by the Sangguniang Panlungsod, as follows:

The Office of the Mayor, through the Traffic Environment and Section 1. Discipline (TED), is hereby authorized to print and issue citation tickets which contain a brief description of all prohibited acts and corresponding penalties prescribed by all ordinances in the City of Muntinlupa.

The Citation Ticket shall be prepared in seven (7) copies. The Section 2. original copy shall be given to the violator, the duplicate copy shall be retained by the apprehending officer, triplicate copy shall be given to the Treasurer's Office and fourth copy shall be given to the Fiscal's Office and the remaining copies shall be distributed according to the other implementors of this ordinance as may be delegated by the City Mayor.

Within thirty (30) days upon the approval of this resolution, the TED is hereby ordered to prepare the necessary implementing Rules and Regulations, subject to the approval of the City Mayor, for the effective implementation of this resolution.

Section 4. The funding for the printing of citation ticket shall be taken from any available funds.
