WHEREAS, Section 454 (d) of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991 states that: *"unless otherwise provided herein, heads of departments and offices shall be appointed by the city mayor with the concurrence of the majority of all sangguniang panlungsod members, subject to civil service law, rules and regulations. The sangguniang panlungsod shall act on appointment within fifteen (15) days from the date of its submission, otherwise the same shall be deemed confirmed."*

WHEREAS, Danilo A. Austria of the Office of Cooperative; Dr. Magdalena C. Meana of the Mayor's Office; Allan A. Cachuela of the Zoning Office; Marylilibeth P. Deloso of the Agriculture Office; and Teresita V. Juan of the Public Information Office are appointed as Department Head III;

WHEREAS, these appointees *meet the required qualifications* under the Local Government Code and Qualifications Standard Book of the Civil Service Commission;




