WHEREAS, the agreed *monthly rental is P25,000.00* effective September 1, 1999 to September 1, 2001;

WHEREAS, *there is a fund available* for the rental of September 1, 1999 to December 31, 1999 from the CDF, 1999 Executive Budget, and from January 1, 2000 from the rental allocated for the LTO, 2000 Executive Budget;

RESOLVE, THEREFORE, AS IT IS HEREBY RESOLVED *to authorize* Mayor Jaime R. Fresnedi *to enter into a Contract of Lease* of the one hundred fifty (150) square meter building and one hundred fifty (150) square meter lot *to serve as office and parking area of the LTO, Muntinlupa Branch,* with Maria Felicidad A. Espeleta.
