WHEREAS, per Bill of Materials the cost of the project is Nine Hundred Ninety Nine Thousand Five Hundred Seventy One Pesos (P999,571.00);

WHEREAS, per certificate and Request for Obligation and Allotment No. 1019911-0544, amounting to Nine Hundred Ninety Nine Thousand Five Hundred Seventy One Pesos (P999,571.00) is allocated for the project from the Infrastructure Projects under 1999 Executive Budget;

WHEREAS, per Resolution No. 99-21 of the PBAC, the project was awarded to V.C. Vera Construction because it won the Public Bidding held on November 17, 1999 with the lowest price of Six Hundred Seventy Four Thousand Eight Hundred Eighteen. Pesos and 38/100 (P674,818.38);

WHEREAS, the Approved Agency Estimate (AAE) for the project is Nine Hundred Ninety Nine Thousand Five Hundred Seventy One Pesos and Forty Nine Centavos (P999,571.49) and the Allowable Government Estimate (AGE) is Eight Hundred Ninety Four Thousand Six Hundred Sixty Six Pesos and Eight Centavos (P894,666.08), respectively,
