WHEREAS, the proposed road concreting located at Soldiers Hills, Putatan, Muntinlupa City, chargeable against Capital Outlay - Infrastructure Projects - under the 1999 Executive Budget is one of the priority projects of the City Government;

WHEREAS, per Bill of Materials the cost of the Project is Two Million Six Hundred Thousand Pesos (P2,600.000.00);

WHEREAS, per certificate and Request for Obligation and Allotment No. 1019911-0542, Two Million Six Hundred Thousand Pesos (P2,600.000.00) is allocated for the project from the Infrastructure Projects under 1999 Executive Budget;

WHEREAS, per Resolution No. 99-18 of the PBAC, the project was awarded to V.C. Vera Construction because it won the Public Bidding held on November 17, 1999 with the lowest price of One Million Six Hundred Sixty Eight Thousand Eighty One Pesos and 38/100 (P1,668,081.38);

WHEREAS, the Approved Agency Estimate (AAE) for the project is Two Million Four Hundred Eighty Six Thousand Eight Hundred Eighty Eight Pesos and Forty Centavos (P2,486,888.40) and the Allowable Government Estimate (AGE) is Two Million Two Hundred Fifty Eight Thousand Three Hundred Ninety Seven Pesos and Eighty One Centavos (P2,258,397.81), respectively;
