WHEREAS, the proposed road concreting located at *St. Villa Carolina I, Tunasan, Muntinlupa City*, chargeable against Capital Outlay – Infrastructure Projects – under the 1999 Executive Budget is one of the priority projects of the City Government;

WHEREAS, per certificate and Request for Obligation and Allotment No. 1019911-0540, *Seven Hundred Forty Three Thousand Seven Hundred Fifty Seven Pesos and 25/100 (P743,757.25)* is allocated for the project from the Infrastructure Projects under 1999 Executive Budget;

WHEREAS, per Resolution No. 99-21 of the PBAC, the project was awarded to *V. C. Vera Construction* because it won the *Public Bidding* held on November 17, 1999 with the lowest price of *Seven Hundred Forty Three Thousand Seven Hundred Fifty Seven Pesos and 25/100 (P743,757.25)*;

WHEREAS, the Approved Agency Estimate (AAE) for the project is *Nine Hundred Eight One Thousand Nine Hundred Twenty Two Pesos and Thirty Four Centavos (P981,922.34)* and the Allowable Government Estimate (AGE) is *Nine Hundred Eleven Thousand Eight Hundred Forty Four Pesos and Sixty Four Centavos (P911,844.64)*, respectively;

RESOLVE, THEREFORE, AS IT IS HEREBY RESOLVED, that City Mayor Hon. Jaime R. Fresnedi *be authorized* to enter into a contract with *V. C. Vera Construction* for the road concreting amounting to *Seven Hundred Forty Three Thousand Seven Hundred Fifty Seven Pesos and 25/100 (P743,757.25)*, located at *Ringgit St., Villa Carolina I, Tunasan, City of Muntinlupa*;






