WHEREAS, per certificate and Request for Obligation and Allotment No. 1019911-0539, One Million Seven Hundred Thousand Pesos (P1,700,000.00), is allocated for the project from the Infrastructure Projects under 1999 Executive Budget;

WHEREAS, per Resolution No. 99-22 of the PBAC, the project was awarded to V. C. Vera Construction because it won the Public Bidding held on November 17, 1999 with the lowest price of One Million One Hundred Twenty Eight Thousand Five Hundred Sixty One Pesas (P1,128,561.00;

WHEREAS, the Approved Agency Estimate (AAE) for the project is One Million Six Hundred Nineteen Thousand Four Hundred Eighty Nine Pesos and Eighteen Centavos (P1,619,489.18) and the Allowable Government Estimate (AGE) is One Million Four Hundred Fifty Five Nine Hundred Fifty Nine and Fifteen Centavos (P1, 455, 959.15), respectively;
