WHEREAS, the proposed road concreting located at *JPA, Tunasan, Muntinlupa City*, chargeable against Capital Outlay – Infrastructure Projects – under the 1999 Executive Budget, is one of the priority projects of the City Government;

WHEREAS, per *Bill of Materials* the cost of the project is *Nine Hundred Twenty Two Thousand, Two Hundred Eleven Pesos and Seventeen Centavos (P922,211.17)*;

WHEREAS, per certificate and *Request for Obligation and Allotment No. 1019911-0541*, amounting to *One Million Pesos (P1,000,000.00)* is allocated for the project from the Infrastructure Projects under 1999 Executive Budget;

WHEREAS, per *Resolution No. 99-19* of the PBAC, the project was awarded to *R.N De Leon Construction* because it won the *Public Bidding* held on *November 17, 1999* with the lowest price of *Seven Hundred Thousand Eight Hundred Eighty Pesos Forty Eight Centavos (P700, 880.48)*;

WHEREAS, the *Approved Agency Estimate (AAE)* for the project is *Nine Hundred Twenty Two Thousand, Two Hundred Eleven Pesos and Seventeen Centavos (P922,211.17)* and the *Allowable Government Estimate (AGE)* is *Eight Hundred Forty Thousand Two Hundred Twenty One Pesos and 11/100 (P840,221.11)* respectively;


