A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. JAIME R. FRESNEDI TO ENTER INTO A CONTRACT WITH R.N. DE LEON CONSTRUCTION FOR THE PROJECT CONSTRUCTION OF OPEN CANAL AT ARANDIA ST., TUNASAN, MUNTINLUPA CITY IN THE AMOUNT OF SEVEN HUNDRED FORTY THREE THOUSAND FOUR HUNDRED FIFTEEN PESOS AND FORTY SEVEN CENTAVOS (P743,415.47).

WHEREAS, the proposed construction of Open Canal located at *Arandia St., Tunasan, Muntinlupa City*, chargeable against Capital Outlay – Infrastructure Projects – under the 1999 Executive Budget, is one of the priority projects of the City Government;

WHEREAS, per *Bill of Materials* the cost of the project is **One Million, Seventy Five Thousand Three Hundred Fifty Two Pesos and Eighty Eight Centavos (P1,075,352.88)**;

WHEREAS, per certificate and **Request for Obligation and Allotment No.1019911-0546**, amounting to **One Million Two Hundred Thousand Pesos (P1,200,000.00)** is allocated for the project from the Infrastructure Projects under 1999 Executive Budget;

WHEREAS, per **Resolution No. 99-13** of the PBAC, the project was awarded to **R.N. De Leon Construction** because it won the *Public Bidding* held on **November 17, 1999** with the lowest price of **Seven Hundred Forty Three Thousand Four Hundred Fifteen Pesos and Forty Seven Centavos (P743,415.47)**;

WHEREAS, the *Approved Agency Estimate (AAE)* for the project is **One Million, Seventy Five Thousand Three Hundred Fifty Two Pesos and Eighty Eight Centavos (P1,075,352.88)** and the *Allowable Government Estimate (AGE)* is **Nine Hundred Fifty Six Thousand One Hundred Fourteen Pesos and Sixty Eight Centavos (P956,114.68)**, respectively;
